# A Quarterly Snapshot: **Employment Services**

"If someone is interested in working, they have a lot of options," says Laura Jardine, Assistant Program Director for Employment Services. Rosemary McShane took advantage of one of those options a few years ago and she could not be happier about it. Starting out in the Prevocational program, Rosemary spent time learning some basic job readiness skills, like the importance of quality work, appropriate social skills, and having good attendance and punctuality.

When she felt she was ready, Rosemary received pointers on how to apply and interview for jobs. Within a short time, she landed a McDonald's lobby attendant position, and she has been cheerfully employed there for nearly five years. For a while, a job coach helped her learn the job duties, as well as how to get to and from her job. Rosemary is independent enough now to no longer need a job coach, but last year, 37 other individuals in the Community Employment program received the support they needed from job coaches to obtain a job or increase their independence at a job site. Fourteen people participated in the Prevocational program.

Rosemary loves her job, especially earning a paycheck and being part of a team. She often encourages other job seekers and shares the many benefits of employment with them.

Although Marie Miller had a different employment journey, she also loves her job and is happy to share her feelings with others. As one of the 30 Associates in Enterprise, Marie works on as-

sembling, labeling, packaging, and scanning jobs for local and regional companies. She is a regular Empowering Abilities

employee, enjoying the benefits of any other employee of her part time status. Prior to this position, Marie had a part-time job in the community, but the hours were inconsistent and there was very little structure. "I appreciate the structure and how the supervisors and managers support us and are always there to help us when needed. The move to this job worked out very well," says Miller.

The Enterprise operation, which now includes the Screen Print and Embroidery Department, has continuously grown in its six years, not only in number of units produced, but in revenue. These trends have provided consistent employment for the Associates, as well as operating revenue for the organization.

Yet another employment opportunity is the Housekeeping Associates. This crew consists of eleven people who are also Empowering Abilities employees. They go to eight different sites, including KWQC studios, some churches, and other area businesses to clean, sanitize, and tidy up the space.

lardine says, "We can assist a person from the time they decide they want to work all the way through to after they land a job and beyond. Like I said, they have a lot of options, and we're here to help them through it all."

## Innovative Projects You Have Made Possible

Empowering Abilities is continuously creating new ways to support people with special needs through innovation, and many individuals and organizations have made gifts or provided grants to make this innovation come alive.

The "Dayhab Re-imagined" project is in progress and is more than you can imagine. Participants in the Daily Discovery West program on Hickory Grove Road can now enjoy their breaktime in a jungle-themed room, complete with a canteen for the kitchen window and various animal faces waiting to be discovered behind trees. Thanks to many generous donors, including the TJX Foundation, who supported this project, each room is taking on a theme that will keep the environment visually interesting for everyone. Special tables and chairs, like mushroom tables in the "Oz" area were made possible from a Regional Development Authority grant. An interactive virtual reality space was partially equipped with VR sets and an interactive projector from a Scott County Regional Authority grant. While there is still much work to be done, the reimagined project is well on its way to becoming something special.

While all that work was in progress on the inside, the "Support the Court" project created opportu-
